Section Chair Report

Hello AWHONN Members and Happy Spring!

I attended a legal talk at the November AWHONN conference. It focused on what the Mom/Baby nurse needed to know. I was surprised that there are a rising number of legal suits that are coming from the immediate postpartum time. Many cases are from sudden unexpected postnatal collapse and newborn falls/drops.

Personally, I have seen practice change from many years ago when I was first a nurse. At that time we took the baby to the nursery for “transition” and the baby was monitored for the first two hours. Now, we protect the “golden hour” and encourage skin to skin which supports transition and supports exclusive breastfeeding. There might only be one nurse monitoring both mom and baby if all is well.

These days many parents are using their smartphones to communicate the information about the birth. With today’s environment there might not be as close surveillance on the newborn as we had previously, and this is thought to contribute to the increase in unexpected events for the newborn. I encourage all Mom/Baby and Labor and Delivery nurses to review the AWHONN practice brief on Newborn Falls/Drops [https://www.jognn.org/article/S0884-2175\(20\)30105-2/fulltext](https://www.jognn.org/article/S0884-2175(20)30105-2/fulltext). Smartphone usage by the parent while holding baby is seen as a contributor to these events. Since attending this lecture I have now started talking to patients about not using the smartphone when holding baby. I mention how we are partnering together to monitor the baby in the very sensitive transition time.

I’m excited that we will be having a legal talk at our state conference. Our agenda is still in process, but we are working on a panel discussion with a lawyer and a few nurses that have worked on cases as legal nurse consultants. It’s a topic we hear from the membership they’d like to learn more about. We will also have a talk on bringing Evidence Based Practice to the bedside. One keynote I know you will enjoy is Stephanie Arnold discussing her experience with surviving an Amniotic Fluid Embolism. I heard her speak at the National Conference in New Orleans. Her message about listening to the patient has stayed with me since that talk and her story is very compelling.



I hope you enjoy this spring newsletter and I look forward to us returning to in person events very soon!

Legislative Happenings



It has been a busy legislative quarter! I was fortunate to attend the AWHONN on the Hill virtual conference. It was very informative and educational. I met the Chair of the National AWHONN Public Policy Committee, Megan Raleigh RN. She recently moved to Colorado from Texas, where she was the legislative coordinator. I look forward to having her expertise in our state!

At the meeting we were given three Acts to ask our Legislators to support. The three are listed below. I had the opportunity to speak with Representative Boebert's personal Aide, it went well. I am hoping to meet with Senator Bennet's Aide later this week and do the same ask.

1. S.411 the Mothers and Offspring Mortality and Morbidity Awareness or MOMMA's Act; this act supports initiatives to reduce maternal morbidity and mortality and improve the health status of women. It addresses racial health disparities and social determinates of health. It would standardize reporting across the states. It would increase postpartum care under Medicaid to expand to a year pp.
2. H.R.1195 Workplace Violence Prevention for Health Care and Social Service Workers Act; This act is asking OSHA to issue a standard requiring health care employers to have a plan in place to prevent violence from happening and respond when it does. This includes de-escalation techniques, personal alarm devices, surveillance and monitoring systems and other strategies to keep employees safe.
3. H.R.958/S.796 The Protecting Moms Who Served Act; this act would require VA facilities to support maternity care coordination with other facilities. It would facilitate access to community resources to address social determinates of health like housing, nutrition, and employment status. Mandating mental and behavioral health risk factors in prenatal and postnatal periods. This would also require VA to offer Childbirth prep classes, parenting classes, nutritional counseling, breastfeeding support, lactation classes, and offer breast pumps.

If you want more information please let me know. You can also reach out to your representative and ask them to support these Acts.

I am sure you are all aware Congress has passed the H. R. American Rescue Plan. This appropriates \$1.9trillion for COVID-19. I was not sure you were all aware of the breakdown that impacts us.

The programs funded by this bill that impact the nursing workforce or the health of mothers and newborns are:

- \$7.66 billion for the public health workforce, including public health nurses.
- \$200 million for the Nurse Corps to support scholarships and loan repayment for students, nurses, and advanced practice registered nurses who work in areas that need them the most.
- \$150 million in emergency supplemental funding for the Maternal, Infant, and Early Childhood Home Visiting (MIECHV) program.
- \$80 million for mental health and substance use disorder training for health professionals, including nurses.
- \$20 million for efforts to encourage healthy work conditions and the use of mental health and substance use disorder services for healthcare professionals.
- \$40 million to promote mental health services among the health professional workforce.
- The bill also allows states to extend Medicaid coverage to 12 months postpartum. The bill makes the option available for five years.

Denver Chapter

Innovation and Collaboration within the SCL System to Promote Safety

As the Denver chapter coordinator and also the Clinical Practice Specialist for Lutheran Medical Center, I wanted to share some exciting innovative changes happening in the front range. Two SCL Health hospitals have joined forces to trial a **remote fetal telemetry unit** to enhance vigilance, create a safety net and promote improved fetal outcomes.

Background about the fetal telemetry project:

In 2020, the SCL Health leadership team recognized an opportunity to improve safety by initiating prompt responses of changing patterns in the strips by centralizing the “monitoring” of fetal monitoring strips. This opportunity specifically focuses on the fetal monitor strips and the ability to identify, interpret and respond to adverse fetal monitoring strips in the Labor and Delivery departments at the respective care sites. This plan includes a 6-month trial of a remote OB Telemetry Room to monitor strips at SJH and LMC in order to improve safety in both units.

Project Details:

The 6 month pilot (March-October, 2021) uses central surveillance of tracings with Perigen Periwatch Vigilance Early Warning System. Periwatch Vigilance offers an FDA cleared software module that measures features in the electronic fetal monitor tracing such as accelerations, decelerations, FHR baseline and variability. During the trial, two experienced L&D nurses are scheduled to staff the remote telemetry room 24/7. The telemetry room is located off the unit in a dedicated area designed specifically to review fetal monitor strips real time.

Outcomes:

Our team plans to collect neonatal outcome metrics evaluating the success of the 6 month trial. If successful, there may be an opportunity to establish a system wide strategy to improve outcomes and reduce risk for the OB service lines in all SCL Health care sites in Colorado and Montana.

Summary:

While too early to determine the success of this pilot project, we are excited to share our passion for fetal safety, innovation using technology and commitment to creative solutions related to women’s health. **We hope this project inspires others to harness your creative energy, passion for safety and**

commitment to collaboration in an effort to improve the health of women and newborns!!

Call for Poster Presentations! (Page 2)

Abstract Submission Requirements

1. Title page:

- Title of the poster. The title should be a concise statement of the main topic.
- Names of those presenting the poster, and the presenting facility.
- Contact information (email and phone number) for the person submitting the abstract. (*Including this information on the title page will allow the abstract to be reviewed blindly.*)



2. Brief description:

Two or three sentences, no more than 75 words, intended for posting on the conference agenda or other program materials to let attendees know what the poster is about. This description should clearly describe your objectives, results and if applicable, recommendations.

3. Two or three Behavioral Objectives:

What should the learner be able to do on completing your session?

4. References:

Reviewers want to see the scientific or academic basis for your presentation, the sources for your assertions. You will be asked to provide at least five (5) references, preferably from peer reviewed sources. At least three (3) of the references should be from the past five (5) years. (References should not be included in the text of the abstract).

5. Author Information:

Please provide contact information, credentials and affiliations for all presenters. The first author and all those presenting must submit a current CV or resume.

6. Poster Guidelines:

Posters must avoid any semblance of commercialism: those constituting promotion and advertising are prohibited. Poster presenters will be provided with a 4 ft. x 6 ft. display board.

Additional Information

Where will the posters be displayed?

Posters are put on display in the conference hall or foyer adjacent to the conference hall. Electrical outlets will not be available.

Do I need to be at my poster during the conference?

Presenters are encouraged to be at their posters and available for questions during breaks.

If I will be presenting a poster at the conference do I, and those assisting me, need to pay to attend the conference?

For those accepted to present, the application fee for attendance at the conference will be waived. This waived application fee only applies to the primary presenter.
